Archbishop To Rome

Pope John Paul II will be invited to visit Miami during his planned trip to the United States in September by Archbishop Edward A. McCarthy next Monday when the Archbishop of Miami will be at the

Archbishop McCarthy will receive the Pallium, symbol of his jurisdiction as Metropolitan of the ecclesiastical Province of Miami which includes five dioceses in the State of Florida, from the Holy Father. A Metropolitan is a "leader among equals" over the other Catholic bishops in the geographical area which is the State of Florida.

The pallium is a circular band of white wool, two inches wide, with front and back pendants, marked with six crosses, and worn around the neck. It is made from the wool of lambs blessed by the Holy Father on Jan. 21, and is worn by the Archbishop on certain feast days and on occasions when he is presiding as Metropolitan in any of the Florida dioceses. The pallium will be blessed by Pope John Paul II on June 29, feast of SS. Peter and Paul.

rickety boats, have come to Miami for refuge and help. The Archdiocese and others have tried and are continuing to try to help those who make it here.

But now the Archdiocese is reaching out across the waters, 700 miles to the small island nation just southeast of Cuba, and to the Diocese of Port de Paix, one of the poorest areas of the country and source of many of the Haitians who have come here.

Members of a local lay group called Amor en Accion (Love in Action) recently visited there and saw the intense need for not only money, but volunteers in the areas of education, health services. agriculture, construction and most any other technical area.

Father Mario Vizcaino, S.P., of St. John Vianney College Seminary, Alicia Marill and Luis Perez, who made the visit, are developing the program as part of their involvement with Amor en Accion at the request of Archbishop McCarthy who has coordinated with the Bishops of

"THE PEOPLE there were kind and friendly in spite of their poverty," said Alicia with obviously heartfelt compassion, "but their needs are so great. There are 7 million people in such a small area. Everywhere you go, even in the rural areas there are people, walking on the roads, going to and from the markets, washing in the rivers. There are no desolate areas.'



Many children in Haiti suffer malnutrition and even dietary brain damage. This one's hair is tinged orange by malnutrition called Kwashiokor disease.

"We visited the House of the Poor," she said, "which was not much different from the other houses — just shacks thrown together - but in this one were 30 to 35 people, all abandoned, people who have no one." The house is provided by Catholic and Baptist missions.

The group also saw at one mission the priests giving out CARE milk to children in exchange for a piece of wood from each child, a gesture that adds dignity to the taking of the milk.

Mission work must be geared to the "integral development" of the person, said Father Vizcaino. "We must help the whole person to develop the ability to stand on their own feet. We are not paternalistic. We give and we learn, it is a sharing both ways.

"And we always work in connection with the local Church," he

Voice readership survey report issued

Recently The Voice commissioned the MAS Advertising and Marketing Services Company of Coral Gables to do a Readership Survey. It was conducted under a recognized set of standards of research methodology with the purpose of establishing the opinion and attitude of the readers toward The Voice, if the readers actually read The Voice, and if so, how frequently?

A SUMMARY of the results indicate that "respondents, on the average, read The Voice 'fairly often." Other highlights of the report

grouped into three categories are:
"Official Church Com-munication, Editorials, Opinion Columns, Know Your Faith and Religious News form the first group. This group is, on the average, liked,

read fairly often and rated as good. Respondents would like to see this group improved, possibly due to the high readership and interest.

"The second group contains South Florida Scene, It's a Date and the Literary writings, poetry, essays, stories, etc... This group is liked less than the first, read less and evaluated slightly less good, on the average. Literary writings (features) is second highest overall in the number of respondents desiring improvement. The other two items are of middle rank.

"The third group contains the TV Mass Schedule and miscellaneous items. Respondents are indifferent towards this group, read them least often and evaluate this group neither good nor poor. Desire for improvement on items or content was not expressed very strongly by respondents.

THE FOLLOWING extract of the full report sent to The Voice by MAS:

a) Definition of the Research: This project addresses to THE VOICE's present reader attitude.

There is a concern with determining THE VOICE performance vis a vis of what the subscribers expected or wanted. The editors have attempted to identify opportunity areas in its content and/or editorials.

In brief, this project attempted to investigate what THE VOICE is to its readers, what they like and / or dislike, what they wanted to improve, if anything, and what is the profile of its readers.

b) Research objectives: The purpose of the research project, then,

was to establish the opinion and attitudes of the readers towards THE VOICE, if the readers actually read THE VOICE, and if so, how frequently.

- The goals of the project were:
 1. To determine the extent of readership of THE VOICE, among its subscribers.
- 2. To determine readers, impressions of THE VOICE, its content and editorials.
- 3. To determine readers' preferences of THE VOICE, content, editorials and editorialists or columnists.
- 4. To determine some socio-economic profile of THE VOICE's readers such as age, income, educational background and occupation.



Archbishop McCarhty's relationship with the bishops of Haiti which came as a result of the 25,000 Haitians now in South Florida.

Bishops sue U.S. on forced abortion law

WASHINGTON (NC) - The U.S. bishops, in a first-ever lawsuit against the federal government, have challenged the government's authority to force private employers to pay for abortions.

The suit was filed in U.S. District Court in Washington June 21 by the National Conference of Catholic Bishops and the U.S. Catholic Conference. It asks for a temporary restraining order blocking the abortion provisions of the Pregnancy Discrimination Act, signed into law in October 1978, and asks the court to rule that the act's abortion provisions violate employers' rights to free exercise of religion.

IT WAS FILED as a class action suite on behalf "of all employers who have objections on moral, ethical or religious grounds to the practice of abortion."

While the Pregnancy Discrimination. Act requires

employers to pay only for abortions in cases where the life of the mother is endangered, the suit alleges that the provision is tantamount to abortion on demand because of the way doctors can abuse the life-of-the-mother category.

And the suit notes that the act forces employers to provide paid time off for all employees seeking abortions no matter whether the abortion is elective or medically necessary.

Named as defendants are the Department of Justice and the federal Equal Employment Opportunity Commission, which in April issued the implementing guidelines for the act.

A spokesman for the U.S. Catholic Conference said the litigation was a "serious step" and marked the first time in the conference's history that it has brought suit against the federal government.

USCC officials said the conference in 1978 supported the pregnancy discrimination legislation because its purpose

was to extend coverage of pregnancy, childbirth, postnatal care and related matters to pregnant workers covered by a health benefits plan.

But USCC officials also noted that the conference had asked Congress to pass a conscience clause so employers or workers would not be forced to pay for practices to which they have strong religious or moral objections. That amendment, the conference noted, narrowly missed passage.

"THE REQUIREMENT that the NCCB and the USCC become the economic means through which abortions are effected, effectively requires those employers to affirm abortion as an illness and a matter of such trivial character as to be considered a fringe benefit," the suit notes.

"Such compulsion is not only an outrageous affront to the conscience of (the USCC and the NCCB), but is also an action on the part of Congress forbidden by the First Amendment," the suit the contends.

The suit contended that to force employers to pay for abortions against their wishes would be like forcing citizens to contribute to political causes they don't want to support or forcing citizens to "advertise ideologic slogans for which they did not agree."

Since courts have ruled that such compulsions are violations of freedom of speech, the court should rule that the abortion provisions of the Pregnancy Discrimination Act are similarly unconstitutional, the suit states.

The USCC apokesman said the conference waited

almost eight months before filing the suit because "there was some reason to believe the guidelines (issued in April) would be better than they were from the point of view of the conference.'

He said the portion of the act requiring employers to pay sick leave for employees obtaining abortions was not in the original legislation.

Voice Readership Survey Report

(Continued from Page 1)

RESEARCH METHODOLOGY

A) Research Design:

In order to be able to answer the questions posed by the research objectives, it was necessary to go beyond the identification of target markets in term of age, income, family size, educational level, etc...In the case of THE VOICE, these dimensions did not distinguish between users and non-users. It was, therefore, necessary to search for new variables to explain user behavior.

In order to translate the attitudinal variables into meaningful marketing goals, it was necessary to investigate the attitudes themselves. A product is perceived as having many attributes, and a buyer can form an attitude about each one. His overall attitude towards the product is a combination of his favorable and unfavorable attitudes towards each of the product's attributes.

In the case of a publication, as in the present case, attitudes provide the basis for an evaluation of the expected utility of the product, not a motivation to acquire it or react to it. Motivation requires an evaluation of a need so that we can develop the way of meeting these needs.

Using the newspaper content and editorials, it was attempted to design an instrument that could identify some salient attributes and needs in term of THE VOICE.

b) Date instrument: The Questionnaire:

The questionnaire was designed to answer the questions posed by the problem under investigation, namely a) extent of readership among THE VOICE's recipients, b) reader's impressions of contents and editorials, c) reader's preferences in terms of contents, editorials and columnists and d) some socioeconomic data.

The questionnaire design was conducted in two stages:
1. Preliminary design and pre-test, and

2. mail-out of sample with final questionnaire format.

The technique used to measure the attributes under analysis was scaling. This technique addresses itself to the problem of measurement, and it is a summated scale

which contains many statements relevant to the object (THE VOICE), but generally, no attempt is made to scale items along an attitude dimension. Instead, each respondent was asked to indicate how strongly he agreed or disagreed with each statement. The statement varied in their degree of favorability or unfavorability toward the attitude object. (For example, Question No.3: "How do you feel about the following items?" and responses ranging from "Like Very Much".)

The score in each item had no meaning unless it was compared with the score of another respondent. The scales' validity and reliability was tested through a pre-test of 20 questionnaires.

The scale used was the Hikert Scale, since this scale is simple to construct and there is no attempt to attain near-interval levels of measurement. The respondents were asked to answer as to the degree to which they themselves agree or disagree with any given statement.

The questions had five choices, such as: Never / Rarely / Occasionally / Fairly Often / Frequently / Like Very Much / Like / Indifferent / Dislike / Dislike Very Much / Very Good / Good / Indifferent / Poor / Very Poor.

The questions were selected according to the

The questions were selected according to the degree to which they were sensitive to differences in the reader's feelings and opinions about the variable being examined.

SUMMARY

Results indicate that respondents, on the average, read THE VOICE "fairly often". Sections of THE VOICE can be grouped in three categories.

Official Church Communication, Editorials, Opinion Columns, Know Your Faith and Religious News form the first group. This group is, on the average, liked, read fairly often and rated as good. Respondents would like to see this group improved, possibly due to the high readership and interest.

The second group contains South Florida Scene, It's a Date and Literary writings, poetry, essays, stories, etc... This group is liked less than the first, read less and evaluated slightly less good,

on the average. Literary writings, features etc. is second highest overall in the number of respondents desiring improvement. The other two items are of middle rank.

The third group contains the TV Mass Schedule and miscellaneous items. Respondents are indifferent towards this group, read them least often and evaluate this group neither good nor poor. Desire for improvement on items or content was not expressed very strongly by respondents.

Columnists were rated positively, even though at times, they were viewed as generally "conventional and uninteresting." Response to

this item indicates that respondents feel that articles are occasionally written in this manner

THE VOICE had greatest penetration among the older, English-speaking readers. These readers also tended to view contents with a very positive but passive attitude. Younger readers tended to be more ambiguous about evaluating contents, but were more inclined to find the readings "generally conventional and uninteresting."

Readership of columnists is fairly equal. The exception is Msgr. James Walsh. Respondents read his column

nearly three to one over the others.

Seventy five percent of respondents spoke English all the time. 19 per cent of respondents are of Spanish origin. 6 per cent of respondents speak English most of the time, meaning English and some other language.

Out of those who speak English all the time at home, 75 per cent feel that a Spanish Section is necessary. One hundred percent of those who speak Spanish all the time, most of the time or combined with English, feel that the Spanish Section is necessary. Eighty-four percent of the balance (those who speak English and other language) feel the same.

Ministry of Christian Service

The following section from an article by Msgr. Bryan O. Walsh, Director of Archdiocesan Catholic Charities and Social Services was inadvertently omitted from last week's article on Ministry of Christian Services:

WE WANT TO see our programs as avenues of cooperation with all our neighbors of goodwill, sharing with each other the task of building up the common good.

We want to see our programs as continuums of loving care, which once begun, continue, through wide spectrums of service to meet people's needs as long as they experience dependency.

Finally, but not least, we want to see our programs as promoting the involvement of all members of our community of faith, according to each one's particular gifts and skills in the corporal works of mercy, to which each is called by the waters of Baptism.

Poor Clares meet in Delray Beach

Six Poor Clare Abbesses and additional Council members gathered recently at Christ the King Monastery in Delray Beach for the annual Council meeting of the Holy Name Federation of Poor Clares. Seven Poor Clare monasteries located on the East Coast comprise the Federation, with Sister Mary Emmanuel, O.S.C., of Christ the King Monastery, as President.

Sister Mary Martin, O.S.C., President of the Western Federation of Poor Clares, the Mother Bentivoglio Federation, was also present for the week. Sister's participation marked the first time inter-federation discussions were held among the Poor Clares.

For three days prior to the Council meeting proper, Father Nicholas Lohkamp, O.F.M., Religious Assistant of the Mother Bentivoglio Federation, conducted a workshop on General Aspects of Formation with specific reference to Formation in the General Constitutions of the Poor Clares.

The topic of formation was followed up in the Council meeting when plans were approved for an inter-Federation workshop for Poor Clare Formation Directresses and team members this July as well as future programs for Directresses to be conducted by The Affirmation House of Whitinsville, Mass.

During the meeting the major items on the agenda included discussion on preparations for the future revision of the General Constitutions of the Order, which are worldwide. Recently up in Stuart, Martin County, ads appeared in the local newspaper with the question. "What has happened to the Catholic Church?" The ads invited people to attend a meeting at the local Holiday Inn and suggested that the speakers would have an answer to the question.

Alleged "local Fatima crusaders" claimed sponsorship of the meeting which was to include a "Missionary priest who tells it like it is." The meeting turned out to be a denunciation of Vatican II. Marriage Encounter: it really works

I'll admit it: I'm skeptical about "movements." I realize that enthusiastically committed collectivities are part of the human condition and make major contributions to human welfare and happiness.

Still, I am with each passing year more concerned about the capacity of a "movement" to impose social control, to require of its members rigid organizational discipline, stern ideological orthodoxy and undeviating behavioral conformity. The only movements that don't scare me are those whose leadership seems to be aware of the risks of manipulation, authoritarianism and depersonalization that are involved in movement enthusiasm.

BUT PRECISELY because movements are enthusiastic, it is very hard for the leadership to be self-critical about social control. On the contrary, much of their energy seems to be consumed by conflicts over internal orthodoxy and then with schismatic groups—the splintering of the original Notre Dame charismatic community is one example of such internal conflict.

I have had the same reaction to the marriage encounter "movement." The technique, it seemed to me, on a priori ground ought to be a very useful one. But turning a technique into a panacea and hard-selling it to others has always seemed to me to be unwise and counterproductive. However, everyone has their own tastes, and because my tastes don't run in the direction of movements is no reason why other people shouldn't be movement enthusiasts.

Recently I had the opportunity to serve on a doctoral dissertation committee. The dissertation in question discussed the impact of marriage encounter—about which, it might be imagined, I was profoundly skeptical. The previous scholarly literature on the impact of all encounter-like experiences appears to indicate that although they may be enjoyable, their effectiveness is not great.

The dissertation by Commander Richard Dempsey, USNR, has persuaded me that the marriage encounter technique may be the most effective brief psychological learning experience yet devised. I continue to have grave reservations about the movement's enthusiasm and the controls it implies, but on the basis of Father Dempsey's brilliant dissertation, I am constrained to admit the marriage encounter folks have something to be enthusiastic

about.

The dissertation surveyed people just before a marriage enocunter, just after it and then six weeks later. The surveyed people were compared with those on a waiting list who had yet to make marriage encounters. Three different tests were administered: a marital adjustment, a marital satisfaction and a self-disclosure inventory. On all three tests, there was no change in the control group and an ex-traordinarily strong change in the marriage encounter group. Moreover, six weeks after the experience the differences between the two groups were increasing. One will have to wait for a follow-up a year after the marriage encounter to make a definitive judgment; but one is virtually forced to say that no psychological training experience described in the literature has that kind of impact.

Commander / Father / Doctor Dempsey explains the power of change by saying that the marriage encounter alone, of all similar techniques, does not isolate a person from the ordinary network of his relationships. The other techniques may really shake a person up because he is taken out of his ordinary network of interaction and dragged through an emotional wringer. In

marriage encounter, however, the principal "other" in any interaction network is also present and in fact the relationship itself is the object of the training experience.

AT ONE TIME the marriage encounter movement was considering elaborate and sophisticated research on its effectiveness. I have the impression that this research did not take place because there was some unease about what the findings would be. On the basis of Father Dempsey's work, I am sure such unease is groundless. Marriage encounter ought to do an elaborate and sophisticated national survey not merely to prove its effectiveness but to obtain better understanding of why it is effective and on whom it is effective. (On one of Father Dempsey's personality tests, the scores continued to rise after six weeks for those who were college educated; the scores didn't go down for those who were not, but they kept on going up for those who were.) Such research, it would seem to me, would be very useful both for the marriage encounter experience itself and for the rest of the country.

Father Dempsey's research has made a major contribution to Catholic self-understanding. Would that there were more such efforts.



Summertime, and ballgames are startin'

It hasn't been the best year for organized sports, especially from the standpoint of sportsmanship. First there was the Woody Hayes "incident" where a coach slugged an opposing player. Next there was a hockey "incident" where the player put the referee in the hospital with a concussion.

Then there was the Indy "incident" where two race car drivers jumped out of their smouldering cars and slapped it out. Then there was the Chuck Fairbanks "incident" where my own University of Colorado ended up with turf on its face, paying an undisclosed but hefty number of dollars to the Patriots to free Fairbanks from his contract at the same time it was cutting faculty and raising tuitions.

But the games go on and they start ever younger. For awhile, there was some medical concern over physical risks to children who became involved in organized sports but a recent study showed that participation in organized baseball has no enduring deleterious effect on the throwing elbow. Interestingly, though, that information taken from the Harvard Medical School Health Letter, ends with a sentence, "Indeed, the psychological trauma exerted on young kids by some coaches and some parents may be of more concern than hard throwing."

The pressure that we see on the part of our culture to win is evidenced by the increasing number of "incidents" like the introductory ones and mirrored on the local level in high school and kid leagues. I suspect that the Woody Hayes action will not be repeated on the national level for a long time but it will surely give more license to local coaches to increase pressure and to lose self-control. Like so many national behaviors, sports incidents come to rest in the home

Dr. Marvin Clein, a University of Denver sports specialist, was quoted on the subject in a McCall's article, "In grade school there's a tremendous need to belong. At that age, being rejected for a team can amount to total rejection. Parents' involvement can also be devastating. The children don't participate because they want to; they do it for the coach or for their parents. Then, when they fail to win, they feel a terrible guilt because they have let someone down."

High school and kid league officials are becoming concerned about the violence and abusive—even obscene—language in evidence at organized sports. A deputy superintendent of an upper income suburban Denver district was blunt in a recent interview. "One problem is that some students are involved in sports programs all year round...and they and their parents have so much

time invested that their performance takes on new significance." He added that the example of crowds at professional events had contributed to the problem. So has the pressure to win.

"These are 16 year-old kids and sports is supposed to be a learning experience," he said, "but they're being pressured into a professional athletic environment...it is appalling to see parents sitting with their kids and bellowing obscenities at the officials or actively interfering with teachers and principals who attempt to discipline kids."

Few of us count ourselves among such parents but we aren't always aware of the pressures we put on our sports-minded children. With a summer season ahead, it's good to scan our own attitudes and behaviors as parents.



'Press Effective Church Communication'

MILWAUKEE-(NC)-Saying homilies and pastoral letters do not meet church needs. communication Catholic theologian Gregory Baum told delegates to a conference on the future of the Catholic press that "the

He said that according to the pope there are three distinct phases in any successful community: solidarity, objections and dissent, and a successful exchange of ideas.





Preparan Ministerio a los Encarcelados

Cristo Está Presente, Nos Espera en Prisiones

Personas cuya dedicación a un ministerio difícil y a veces olvidado sirve de testimonio para su fe, les dijeron a representantes de diversos grupos laicos de la archidiócesis que Cristo está presente de una manera muy especial en las prisiones y en el ministerio a los encarcelados.

"Jesucristo fue prisionero y

"Jesucristo fue prisionero y murió prisionero en la silla eléctrica hace 2,000 años," dijo el Padre John O'Connor, que ha dedicado la mayor parte de sus 48 años de sacerdocio a trabajo en las prisiones. Los encarcelados, dijo, "son seres humanos igual que nosotros que necesitan ayuda."

Esa 'humanidad' del prisionero y la escasez de voluntarios dispuestos a cometerse firmemente a ayudar, fueron los temas centrales de la conferencia sobre la justicia criminal que tuvo lugar el sábado en el Seminario de St. John Vianney. La conferencia marca el comienzo de un programa de ministerio a los encarcelados en la Archidiócesis de Miami.

A la conferencia asistieron, además de los Obispos Auxiliares Agustín Román y John Nevins, quien dio la bienvenida en nombre del Arzobispo Edward McCarthy, laicos del movimiento de Cursillo y del sistema penal, así como representantes de otras organizaciones de la archidiócesis.

Según el Padre Steven Staudenmeyer, Director del Programa de Ministros a Prisiones, esta primera reunión tenía como fin reunir a las personas que ya están envueltas en ese ministerio para que les hablaran e informaran a las que están interesadas.

La meta del Programa de Ministerio a las prisiones es coordinar los esfuerzos de los individuos de diferentes organizaciones laicas para traer un ministerio organizado a las cárceles de la archidiócesis.

cárceles de la archidiócesis.

Pero antes de alcanzar este fin, la comunidad necesita cambiar su opinión acerca de los prisioneros y las cárceles.

"Tratamos con los delincuentes de la sociedad," dijo Jack Sanstrom, Director de la Cárcel del Condado de Dade, "y gran parte de la sociedad preferiría que se los encarcelara y olvidara."

"Pero todos nosotros, hasta cierto punto" podemos considerarnos encarcelados, dijo, ya que "todos tenemos problemas," la única diferencia es que los de los encarcelados son más graves.


Sanstrom y Tom Kehoane, Guardia de Instituto Penal Federal de Miami, opinan que es realmente necesario que las religiones organizadas y sus miembros laicos se dediquen al ministerio a los encarcelados.

Keohane, que ha experimentado en las cárceles con programas de ayuda al individuo como por ejemplo el Análisis Transcendental, la Meditación Transcendental y EST, está convencido de que "el único programa que al fin y al cabo lo tiene todo es la religión...Lo que verdaderamente hay que hacer para los encarcelados es unirse espiritualmente a ellos."

Paul Turcotte lleva 14 años de unión espiritual con los prisioneros de la Cárcel del Condado Dade. Los visita cada semana llevándoles "el amor de Cristo" y recordándoles que ellos sí son importantes.

Pero Turcotte dice que las conversiones instantáneas son pocas y que los voluntarios deben trabajar mucho para poder

Unidad No Significa Uniformidad

CIUDAD VATICANO — (NC) — "La unidad — a nivel universal o local — no significa uniformidad o la absorción de un grupo por otro," dijo el Papa Juan Pablo II durante su audiencia con una delegación de la Iglesia Cóptica Ortodoxa de Alejandría, Egipto. Depués repitió este mismo mensaje para un grupo de misioneros católicos.

La unidad "se debe expresar en diversas formas," dijo el Papa a los cópticos y añadió, "Tenemos que sobreponernos al escándalo de la división."

El Papa llamó al Papa Shenouda III, Patriarca Cóptico de Alejandría, "mi hermano" y dijo que estaba "contento de poder hacer míos los pronunciamientos de la declaración común'' firmada en 1973 por el Papa Shenouda y el Papo Pable VI

pa Pablo VI.

"Nos alegramos por habernos sobrepuesto a las dudas y sospechas de años pasados y con corazones llenos proclamamos juntos otra vez esta verdad fundamental de nuestra fe cristiana," una creencia común en Jesucristo, dijo el Papa.

El Papa dijo que considera uno de sus mayores deberes el trabajar "por la unidad de todos los que llevan el sagrado nombre de cristianos." Ese mismo día, hablando con miembros de los institutos de los Hijos del Sagrado Corazón y Misioneros del Sagrado Corazón, que después de 55 años de división se reunían por primera vez, el Papa dijo que los misioneros "están en este mundo pero no son de este mundo."

El gobierno ha acordado poner en vigor las provisiones del Acto hasta que las cortes escuchen la demanda este cinco de julio.

Los obispos presentaron la demanda a nombre de "todos los patronos que tienen objeciones morales, éticas o religiosas contra la práctica del aborto."

Mientras que el Acto contra la Discriminación por Embarazo sólo obliga que los patronos paguen por abortos en ocasiones donde la vida de la madre peligra, los obispos alegan que la provisión equivale al aborto por cualquier razón, ya que los médicos abusan la provisión sobre la vida de la madre.

Los obispos también hacen notar en su demanda que el Acto obliga a los patronos a pagar a sus empleados por el tiempo que éstos estén fuera del trabajo debido a un aborto, sea éste necesario o no.



ganarse la confianza de los encarcelados.

"Todos tenemos a Cristo y ese Cristo tiene que brotar de ellos. Si vamos (a la prisión) esperando cambiar el mundo, perdemos nuestro tiempo. Tienes que ir con el amor de Dios en tu corazón. Debes tener paciencia, tienes que perseverar," dijo Turcotte.



Tom Johnson, Director del Movimiento de Cursillos, que ha celebrado cinco con los prisioneros de Raiford, dice: "Te encuentras con personas que generalmente se han dado totalmente por vencidas y entras y les dices 'te queremos y Dios te quiere' y cuando ellos aceptan esa realidad es la experiencia más bonita que un individuo pueda tener".

Milan Kralik, capellán de la Institución Penal Federal, piensa que el voluntario debe actuar como catalista. El capellán está para enseñar, predicar y dar los sacramentos' pero los únicos que pueden llevar la verdadera religión a los encarcelados son los voluntarios.

"Ustedes son los importantes. Ustedes como seres humanos de sangre y hueso pueden ser ejemplos para los encarcelados de como vivir vidas buenas, guiadas por Dios. Dios te ha dado vida y Dios te ha dado la oportunidad de amar y perdonar, y ahora ellos pueden comenzar a hacer esto en sus propias vidas," dijo,

Roberto Pérez, capellán de la Cárcel del Condado Dade, dice que la unión entre el preso y la persona es el elemento básico para cualquier conversión. "Quieren saber si eres 'de verdad'...Si realmente practicas lo que profesas como cristiano."

El Padre Sean O' Sullivan, Profesor de Criminología en el Seminario St. John Vianney, propuso un plan para la formación de un Instituto de Justicia Criminal Católico en la Florida. El instituto constará de una Junta Directiva bajo la dirección del Arzobispo McCarthy, compuesta

de representantes de los diferentes sistemas que se relacionan con el sistema penal. Entre éstos estarán oficiales penales, jueces, hombres y mujeres de negocios, policías y representantes de agencias de salud pública, salud mental y educación. También habran representantes de Alcoholicos Anónimos, Cursillo, Movimento Carismático, Centro de Enriquecimiento Familiar, Ministerio Laico, Diaconado Permanente, seminaristas, la sociedad de San Vicente de Paul, La Legión de María y el Concilio de Mujeres Católicas.

El instituto se encargará de añadir un curso de criminología a los demás cursos de entrenamiento de laicos de la archidiócesis. Aunque el ministerio a los encarcelados constiuirá "la piedra angular" del instituto, el Padre O'Sullivan dijo que también habrán ministerios para los policías, jueces, hombres y mujeres de negocios y familias, así como un ministerio que abogará por una actitud más humana con los prisioneros y personas condenadas a muerte.

Toda esta organización tiene como meta unir a los diferentes sistemas que afectan las vidas de los prisioneros ya que muchas veces la falta de unión y entendimiento entre los diversos sistemas hace imposible que los encarcelados reanuden una vida normal al salir de la prisión, dijo O'Sullivan. No todos los que quieren trabajar con los encarcelados podrán hacerlo, sin embargo, ya que se trata de un ministerio muy difícil.

Ministros para las prisiones serán cuidadosamente entrenados y escogidos.



La práctica pública de sesiones espiritistas, con manifestaciones llamadas mediúnnicas, ejerce sobre la mayor parte de los asistentes una intensa tensión emocional y en los predispuestos (psicópatas, neuróticos, fronterizos, desajustados de la afectividad) es la denamiento de reacciones que llevan al pleno terreno patológico'

influencia nefasta del espiritismo se ejerce con tamaña intensidad sobre la salud mental del pueblo como ocurre entre nosotros... Inclusive un caso de muerte fue observado hace poco en Río de Janeiro, por causa de traumatismo psíquico.. En el ejercicio de más de veinte años de clínica psiquiátrica en nuestro medio, hemos observado un sinnúmero de débilies mentales, suges-

tionables y crédulos, incapaces de un juicio crítico severo, presentar síntomas delirantes después de presenciar sesiones espiritistas o participar activamente de ellas".

Es lógico que el desenvolvimiento normal de la actividad humana se efectúa en el terreno consciente. El inconsciente es algo desordenado, inexplorado, se manifiesta por su propia cuenta y riesgo.

Nunca lo podemos dominar, ni medir las implicaciones profundas de sus manifestaciones. Es irresponsable. Por lo tanto, la actividad humana debe ser lo más consciente, lo más controlada posible.

Según los especialistas, los fenómenos en cuestión surgen en la región completamente inconsciente. Intentar fomentarlos es exponerse a la posiblidad de que el inconsciente tome cuenta, cada vez más, de la personalidad. Esto traerá consigo una actuación irresponsable e incontrolable, que irá aumentando el desequilibrio psíquico.

Siendo el inconsciente incontrolable, junto con los fenómenos, puede surgir una serie de traumas latentes. Estos traumas, que se encontraban ocultos, sin actuación, con el cultivo de los fenómenos vienen a la superficie. Si ya eran manifiestos, pueden agravarse. Haiti, el país más pobre del Caribe, necesita mucha ayuda. Y la Iglesia de aquí se la va a dar.

Are we all burglarproof?

This section is concerned with security in the home, and it may well be wondered why in a Catholic newspaper. We can only answer that crime knows no religion, nor the religion of its victims.

It is crime and criminals which are of great concern to the average citizen. This because criminal activities are on the increase, especially burglaries, robberies, mugging and the like. People of all ages are its victims.

THERE ARE no safe neigh-

THERE ARE no safe neighborhoods or safe houses. Each of us knows of the neighbor down the street or next door, or even have our own experiences of burglary and the

losses that generate from it. Sometimes such a loss is material; more tragically, it can be one's very life itself.

The following few pages, therefore, are dedicated to encourage people to take the necessary precautions to protect themselves and their property from the criminal intruder. Again, he or she is no stereotype. He or she is not necessarily a derelict; neither are they of any particular color. They can be in old clothes or business suits — and they range from the professional burglar to the amateur.

Motives also are of a variety. It might be just for "kicks" or to sustain a drug addiction, or because

it is a way to make a living by people who want something for nothing. Whatever, the burglars are in our neighborhoods, prowling our streets, looking for places to enter and to rob. Obviously, we would be fools if we had the attitude that it can never happen to us, or if it has happened once, it won't happen again. Crime history proves us wrong.

history proves us wrong.

It was all put rather startling but realistically in a book we recently read by James E. Keogh and John Koster, (Burglarproof — a Complete Guide to Home Security).

They said: "Let's face facts. You

They said: "Let's face facts. You can expect to have your home burglarized twice in your lifetime. This statement is based on randomized statistics of present crime figures.

figures.
"OBVIOUSLY, burglaries in a lifetime are two more than anyone should have to put up with, but that's not the worst part of the story. Crime figures have been on a drastic increase since the 1960's and show no signs of leveling off. From 1960 to 1970, the last census year, the population increased 13 percent while the crime rate increased 144 percent. Since 1970, population growth has slowed down, but the crime rate has continued to increase. By 1980, you may expect your home to be burglarized three times, four times, or even more often.


"Burglary, like lightning, all too often strikes more than twice. Some people who live in inner cities, or even in some suburbs, wouldn't find two burglaries a year to be out of the ordinary. And those who can least afford to be plundered, the wage-earners who have a hard time replacing their few luxury items or senior citizens on fixed incomes, are the most frequent victims.

"Burglary, like all other crimes, is spiraling. The real reason for the increase in burglary is that it's an easy way to make a good living if you aren't afraid to run a few risks and work thusual hours. Through their innocence or ignorance, or through apathy, most home-owners or apartment dwellers make it so easy for a burglar to rip them off that he'd have to be crazy to consider honest work.

work.

"Make no mistake about it, to be burglarized is an unpleasant experience. Besides losing large amounts of private property—and believe it or not, replacing the losses of disposable valuables from even a middle-income home can run into thousands of dollars—there is a profound sense of shock attached to coming home and finding your living room and bedrooms torn apart and your treasured possessions carted off to no-one-knows-where, or broken and scattered all over the floor.

"For many people, a burglary can cause a worse emotional trauma than a serious car crash or the death of a relative. There is also the unpleasant but distinct possibility that you may surprise a burglar in the process of robbing your home. In most cases, nothing will happen, but some burglars — particularly the younger, crazier one in slum areas, who have no respect for any human or legal sanction — make it a practice to kill anyone who comes upon them in the act. Savage beatings and rape, though not common, are also quite possible.

"Ali in all, it's worth a lot of time and energy, and some expense, to avoid being burglarized.

A SIMILAR position is taken by Val Moolman, a consumer research consultant, who in a book entitled Practical Ways to Prevent Burglary and Illegal Entry, said:

"No doubt much of what has been said about self-protection and the protection of property will strike some readers as exaggerated. All those locks and bolts and bars and sirens? Such extreme caution to enter our own homes, operate our own automobiles, mind our own business? Must we really jail ourselves in our homes, our apartments, and even in our hotel rooms? Shame? What are we, a nation of neurotics?

Well... A nation of thieves, maybe. But whatever we call ourselves, national crime statistics show that it is difficult to be over-cautious. Many of us may be fortunate enough to go through life without once being burglarized, or without once having to report the theft of an automobile. But luck must be guarded as carefully as anything else. If we don't look after it, we won't have it forever. All of us — every householder, every businessman, every career girl, every car owner, every traveler must make sure of our continued good luck by protecting it with every security measure we can reasonably take. Spending a little money and taking some simple precautions are small investments against heartbreaking loss.

National Burglary Prevention Month

The following article was written by Sergeant Gerald A. Rudoff of the Dade County Public Safety Department. We publish it as a public service.

Burglary warnings were sounded by the Public Safety Department as area residents enter the normal vacation period.

The Public Safety Department asked all citizen's cooperation to help reduce the surge in burglaries which result each summer, when families leave their homes for vacation trips and weekend outings. "By learning and practicing a few simple home protection hints, residents can keep their homes from falling victim to a burglary", they

THE MONTH OF June 1979 has been declared "National Burglary Prevention Month". During this month your Police Department will provide information to help you protect your home from burglars.

Failure to know and practice the fundamental techniques of home protection was largely responsible for the 13,993 (Approximate number) burglaries committed in unincorporated Dade County last year. Although most people didn't intentionally invite intruders to ransack their home, they might as well have hung up a sign saying, "No one's home, burglars welcome."

A stroll around your neighborhood any day, will tell you at a glance who's away, their porches will be cluttered with circulars, an accumulation of milk bottles on the stoop, and unkept lawn, an empty garage with the door open or a bulging mailbox. All of these are tipoffs that'll broadcast "no

one's home'' to anyone canvassing the neighborhood.

In the evening, most empty homes can be spotted too — just look for the dark houses. It's a known fact, light is one of the best deterrents to crime, yet most homeowners go out for an evening and leave their homes completely dark. Or, they'll go off for a weekend or vacation and leave the same light burning day and night. No light at all, or a light burning continuously, is a good giveaway "no one is home".

A SIMPLE, BUT ef-

A SIMPLE, BUT effective means of having light in your home every evening, is by connecting an automatic timing device to one or two lamps. Such a timer will turn a lamp "on" early in the evening, then turn it "off" several hours later. With lights turning on and off during the evening hours, it will give the appearance someone is home and may avert a possible burglary attempt!

Most burglars pick the easiest targets they can find. They want to get in, get the loot and get away as quickly as possible. Therefore, if you put several obstacles in his way, he is less likely to try to break into your home, but will seek "easy pickins" elsewhere. By observing these few simple precautionary steps, you can reduce the possibility of a burglar selecting your dwelling as his target next time you're away.

• Close and lock all doors, including porch and garage. Use pin tumbler cylinder locks on outside entrances and safety latches on the windows.

• Connect a lamp to an automatic timer to turn lights in the home on and off each evening. Since noise is

deterrent, connect radio to a timer.

• Light up your porch and yard with outdoor lights to increase the likelihood that an attempted burglary would be seen. These lights can also be timer-controlled, if desired.

be seen. These lights can also be timer-controlled, if desired.

• Be sure all screens are fastened from the inside.

 Never leave valuables lying around, keep them in a safety deposit box.

• Notify your police department when you'll be leaving and how long you expect to be away.

• Inquire about the Public Safety Department's Watch Order Program from the substation in your area.

• Cancel all deliveries, such as the milk, laundry, cleaning, etc. Also, be sure to discontinue the newspaper or arrange to have it sent to your vacation address.

• Have a neighbor, or your post office, hold all mail until your return.

• Arrange with a friend to mow the lawn and sweep your sidewalk once a week. Also ask him if he'll pick up any circulars or handbills that may be left on your porch.

• Leave your shades and blinds as you normally do, closed blinds keep the sun out, but also make an effective screen for the burglar.

• Never advertise your departure with an item in the local paper. Give the story about your vacation to the newspapers after you've returned.

• Make arrangements with a neighbor to know your whereabouts and how to contact you in the event of an emergency.

THERE IS NO such thing as "burglar proof" home, however, citizens should take advantage of free services provided by the Public Safety Department in which they can have a security survey of their homes. An officer trained in residential security will point out weak spots and make recommendations for better security. He will also discuss the Operation I.D. Program in which citizens can mark personal property with their Florida driver's license number. Engravers are provided on a loan basis free of charge from District Substations.

The Public Safety Department also encourages citizens to join the successful Citizen's Crime Watch Program. Over 50,000 Dade residents are members. They report suspicious activity in neighborhoods to police and have been credited for reporting crimes in which burglars have been arrested and property recovered. For further information concerning Crime Watch call 871-4650

For any information regarding Burglary Prevention and or Security Surveys in unincorporated Dade County, call the Public Safety Department, Community Service Section at 547-7496. For those residing in municipal areas, contact your local police departments. In addition, information and service can be obtained for those residing in unincorporated areas by contacting the substation located closest to your home.







Burglar Alarm Steal Home Security Spotlight

New York - Consumers protected by the familiar smoke detector may soon be wondering if their house is burning or burgled once a host of new beeping machines hits the market this

With smoke alarms already well established through price cutting that has drained much the market's profitability, General Electric, Norelco and other survivors of the smoke detector rebate wars are looking at burglar alarms as the next generation of security products.

THESE TWO

companies represent, perhaps, the first attempts to crack a market served until recently by expensive, custom-installed syscustom-installed systems. Both GE and Norelco place high priority on "preempproduct tive" troductions and advertising, but neither expects to be alone for

GE estimates retail sales of \$90,000,000 for the burglar alarm in-

dustry this year. Frost & Sullivan, a New York market research company, has pegged the market growing to \$200,000,000 by 1985, The diversity of burglar alarm technology – a confusing array of devices to a largely unfamiliar public - may ultimately protect burglar alarms from price slashing at the same time that it slows down the product's initial acceptance.

It's not a com-modity product like smoke detectors, and we're consciously going to avoid advertising it that way, "GE's that way, "GE's Thomas Albani, general manager housewares marketing department, said of the company's Zonar alarm, due at retail in June.

Zonar, priced at \$69.95, sets up a beam of ultrasonic waves which, when broken, trips an alarm. This type of unit is designed to protect a broad area, rather than a specific point of entry, and, as such, is known as a "space protector."

"TRUE VOLUME has not been achieved to

A word about security

The word security, as it is used by those in the business of designing and installing home protection devices, refers to deterrents installed as defense against possible danger or damage to people or property. A deterrent may range all the way from a simple locking device to a complicated alarm system, and several different deterrents might be desirable. Many burglaries are attempted by opportunists. A burglar of this type cannot afford to take the time to break a quality locking device nor can he risk making noise to effect a forced entry. In such a situation, the home or apartment owner is protected if unwanted entry can be deterred for just a few minutes. A few basic security precautions will normally accomplish this.



Prison Ministry Needs Witnesses


Christ is present in a very special way in prisons and in the prison ministry, representatives from lay groups of the Archdiocese were told during a Criminal Justice Institute held Saturday at St. John Vianney College Seminary. And they were told by people whose dedication to this often neglected ministry gave

witness to their words.
"Jesus Christ was a prisoner and died a prisoner in the electric chair 2,000 years ago," said Father John O'Connor, who has worked in prisons or with prisoners for most of his 49-year career as a priest. Prisoners, he said, "are human beings just like us who

need help."
THE HUMANITY the prisoner and the need for people willing to make a firm commitment to help were the basic points made during the seminar, whose purpose was to kick off a prison ministry program in the Archdiocese of

Miami.
Present at the seminar, in addition to Auxiliary Bishops Agustin Roman and John Nevins, who welcomed the participants on behalf of the Archbishop, were lay people from the Cursillo movement and the correctional system. as well as representatives of other Archdiocesan organizations.

According to Father Steve Staudenmeyer, Director of the Prison Ministry



Program and Coordinator of the Institute, this first meeting was a kind of "brainstorming" session, where those who are already involved with prison ministry could meet with others who want to become involved.

The goal of the Prison Ministry Program is to coordinate the efforts of individuals in the different lay groups of the Archdiocese and bring an organized ministry into the many prisons of the diocese.

BUT BEFORE anything can happen, people need to be informed; the community needs to develop a new attitude towards prisons and prisoners.

"We deal with the derelicts of society," said Jack Sanstrom, Director of the Dade County Jail, "and a lot of society would just assume they were put away, locked up and forgotten."

But an inmate, he said, "is all of us a little bit. We all have our problems," theirs are just accentuated.

Sanstrom and Tom Keohane, Warden of the Federal Correction Institute in South Miami, both feel there's a definite need for organized religion and lay people from the community to get involved in prison ministry.

After experimenting personally and in prisons with programs such as Tran-scendental Analysis, Transcendental Meditation and EST, Keohane feels "the only program that really has it all the long run religion...What you really need to do for people who are confined is involve yourself in a spiritual sense with them.'

PAUL TURCOTTE has been involved spiritually with prisoners in the Dade County Jail for 14 years. He visits them every week, taking "the love of Christ to them," telling them that he cares.

But he advises that instant conversions are rare, and that a person must work long and hard before he or she can even begin to be trusted by the inmates.

"We all have Christ and that Christ has to be brought out of them. If we go there to the prison to change the world, we're wasting our time. You have to go there with the love of God in your heart, you have to be patient. You have to persevere," said Turcotte. Milan Kralik, chaplain of

stitution, feels the role of the volunteer is that of a catalyst. The chaplain can be there to 'teach and preach and give the sacraments" but the only ones who can convey a sense of "real religion" to the inmates are the lay volunteers, the other staff members.

"IT'S YOU (volunteers) that are important." said Kralik. "You as a flesh and blood human being that these men can identify with and can see how you live your life successfully and see that a good part of your motivation comes from God. God has given you life and God has given you the opportunity to love and forgive them and now they can begin to do this in their own lives.

Roberto Perez, Chaplain of the Dade County Jail, agrees that the involvement of the person is the most important element before any conversion can take place. 'They want to know if you're for real...if you really mean what you're professing as a Christian. Modern man learns not by teachers but by witnesses.

Tom Johnson, a leader of the Cursillo movement, has been involved in five Cursillos given at Raiford, the state penitentiary. He has experienced the feeling of community that a Cursillo can bring to a prison, and he says the prisoners are not the only

ones who gain.
"You come across people who've generally written themselves off and you come in and say we love you and God loves you and when they accept that reality it's the most beautiful experience that an individual can have," said Johnson.

FATHER SEAN O'Sullivan, Professor of Criminology at St. John Vianney Seminary, proposed an organizational plan for a Florida Catholic Criminal Justice Institute which would include a Board of Governors under the leadership of Archbishop McCarthy, composed of representatives of the different systems that deal with the correctional institutions.

Included are corrections officers, judges, businessmen, enforcement personnel representatives from mental health, educational and health agencies, as well as from programs such as

Alcoholics Anonymous. Charismatic Cursillo, Movement, Family ment Center, Lay Ministry, Deaconate, seminarians, the St. Vincent de Paul Society, the Legion of Mary and the Council of Catholic Women.

The Institute would also provide an additional resource, that of criminology, to the existing lay training programs of the Archdiocese. Although prison ministry would be the "cornerstone" of the Institute, said O'Sullivan, there would also be related ministries for law enforcement personnel, judges, businessmen, and families as well as a Ministry of Advocacy which would work for a more humanizing approach to prisoners and people on death

The whole aim of the institute is to fill in the gaps between all these related systems so that no one will fall through, said O'Sullivan.

The program takes into account the fact that not everyone who wants to can work with those in prison, and those present agreed that before anyone could become a prison minister, he or she would have to be carefully screened and trained.

THE NEXT meeting of

the Institute will be on August 6 at 7:30 p.m. at St. John Vianney Seminary.

Reception for Sister Dorothy

Among them was the 1972 Silver Medallion Award of the Florida Region National Conference of Christians and Jews, and honorary doctor of letters degree from Biscayne College, and the first Lumen Christi award from the Archdiocese of Miami Catholic Teachers' Guild.

The reception host will be the Barry College Alumni Association. Sister Dorothy will be on campus for several days preceding the reception. She is still active as a teacher in Illinois.

Home Security Check List



LEAVE your shades and blinds as you normally do. Closed blinds keep the sun out, but also make an effective screen for the burglar.

NEVER advertise your departure with an item in the newspaper. Give the story NEVER leave valuables about your vacation to the newspapers after you've returned.
